REGULATIONS GOVERNING **THE ORGANISATION AND PRESENTATION** **OF** Leitrim County Football Championships 2007

1. Grounds will not be opened until one hour in advance of first fixture of double header or single fixture.
2. Team lists for programme purposes to be sent to Committee in charge no later than Wednesday noon in advance of game. Players must line out according to programme numbers. **Penalty for Breach of Regulation: €100**
3. A maximum of 38 passes for pitch enclosure for all First Teams of clubs in championships will be issued to each club at venue on day of game. Passes for second, third and fourth teams will be issued at gate by county committee official to players and officials as they arrive.
4. Club Official responsible for distributing passes to first teams should be at ground in advance of arrival of players as they will not be admitted to ground without pass.
5. Games must be started at appointed time as per TO 2007. Clubs are advised that they must take the field in sufficient time to allow games to start on time. **Fines as per Rial 114 TO 2007**
6. All substitutions to be made only with the permission of linesman.
7. High numbered jersey to be saved to replace blood stained jersey.
8. St. Mary's club grounds will not be available for warming up of teams playing in Páirc Seán Mac Diarmada.
9. Two water carriers allowed per team. Clubs are advised that water carriers are obliged to supply water to players from both teams, when requested. Any noted infringement of this regulation will incur a penalty. **Penalty for Breach of Regulation: €50**
10. Teams shall occupy the dug-out or designated seating area as instructed by the Committee in Charge of the fixture. **Penalty for Breach of Regulation: €100**
11. The following officials only shall be allowed entry to the playing area for the duration of a game, and **must** be named on the Official Team List handed to the Referee: (a) Bainisteoir and Roghnoiri (b) Medical Person (c) Cathaoirleach club (c) Runai Club or nominated representative (e) Maor Uisce x 2 (Must be 16 or older). **Penalty for Breach of Regulation: €100**
11. **Team Mentors**

Team Management Officials may move alongside the sideline, the opposite line and endlines to make changes and/or to give instructions to players.

These Officials may not

- (i) interfere with play
- (ii) remain behind the goal area
- (iii) engage in any behaviour which, is deemed by the Committee in Charge, to interfere with the control of the game by Referee, Linesmen, Umpires, Sideline Official/Field Officer.

(b) A Team Medical Officer shall be clearly defined by wearing a distinctive bib (supplied by the Club). This person should only enter the field of play to assist an injured player with the permission of the referee.

Exception: Case of emergency injury.

The Referee is advised to delegate authority to the Linesmen to assist him in this case i.e. serious injury on the field of play.

(c) The Referee or other Official(s) appointed by the Committee-in-charge shall report any unauthorised entry on the field of play.

Penalties Regulation 11

(i) Offenders reported by the Referee for unauthorised entry on to the field of play may be dealt with under Riail 114 (e) T.O. 2007.

(ii) For breaches of Regulation 11 other than those dealt with under Riail 114 (e), offenders may be excluded from the Pitch Enclosure and dressingroom area for the game's duration but not including half time interval, for future games as determined by the Committee-in-charge.

(iii) Fine - €100
