1) (a) Postponements will be granted only on the death of a club player/official or immediate family member (parent, brother, sister, spouse, child) of either.

Exceptional circumstances may also be considered.

(b) Responsibility for communicating with the CCC will lie with club seeking the postponement. When a game is postponed the referee will be notified by the CCC.

(c) No individual member of the CCC is allowed sanction postponements or alter fixtures.

(d) Where a postponement is granted by Leitrim CCC, the game shall be re-fixed at the earliest opportunity as determined by the CCC.

2) All fixtures shall be co-ordinated by the Chair and Secretary of CCC in between CCC meetings.

3) **Only Correspondence by email from Club Secretary to Secretary of CCC shall be considered.**

4) Clubs that re-arrange a fixture without the permission of CCC shall lose the game/points as appropriate.

5) Failure to fulfil a league fixture as instructed by the CCC will be dealt with in accordance with GAA Code 13.2 2024.

Penalty for each unfulfilled Fixture: Award of Game to Opposing Team;

Divisions 1A, 1B & 2: Minimum Fine €200.

Maximum Fine: Double each of the respective fines.

6) GAA Code 13.2 2023 together with GAA Code 11.1(5) 2023 will determine League Table placings in Spring Leagues.

7) Late starts will be penalised as per GAA Code 15.2 2023.

8) Failure to have pitches properly marked by the hosting club will result in fines. **Minimum Fine: €50.**

9) In the League if the Home team's pitch or nominated home team's pitch is unplayable they must travel to their opponent's pitch. If the opponents pitch is unplayable the CCC will decide on an alternative venue; ample notification must be provided by the club to facilitate such a situation, the latest time for notification by a club being 9am on the morning of the game. Match points to be awarded against any team refusing to field.

10) In the event of a clash of club colours for a league fixture both teams shall change to their registered alternative colours. If both clubs are in agreement, teams may agree to toss a coin to determine which team shall change jerseys. The CCC shall be the deciding body in determining whether or not a change of colours is warranted.

11) (a) The top team in Division 1A & 1B respectively of Spring League Competitions will contest the Division 1 League Final. Toss for home venue. Gate receipts to be shared equally between the participating clubs. The bottom team in each division will be relegated to Division 2 for following Spring League season.

(b) Division 2 in 2024 will consist of eight teams. Each team will play four games, decided after a randomised draw, two home and two away. At the end of the four rounds the top two teams will contest the Division 2 League Final. Toss for home venue. Gate receipts shared equally between the participating clubs. The team that finishes top after league stage will be promoted to Division 1A, and the second placed team will be promoted to Division 1B.

12) In Division 2 of the Spring League, Ballinaglera and Cloone to be allowed deviation from Official Guide Part 2 Rule 2.1 Rules of Specification, Playing Rules. That is to say that on any given League Match Day, if these teams only, have not the required 15 players to start a game, then that match will be played from commencement to conclusion at 13-a-side. In these cases, the maximum number of players that will be available to the team which has triggered this deviation from rule will be 15. No other players who become available at any stage during that game will be allowed to join the game with this team. Use of 16th player shall lead forfeiture of game on a proven objection with award to the opposition or forfeiture of game without award to the opposition on an investigation by the committee in charge. All Play Off and League Final games must be played at 15-a-side, while taking into consideration what is stated at Rule 2.2 TO 2023 Part 2.

13) Winner On Day scenario shall apply to all Finals.

14) The CCC shall determine in what order the rounds of League games are played.

15) At the conclusion of the regular rounds specified any ties shall be decided in accordance with GAA Codes 13.2 and 11.5(5) 2023.

As our 3 County Panels are training and participating in their respective Championships while these Spring Leagues are ongoing the following regulations will apply:

16) No County panellist from the 3 active County panels will be available to their clubs for the duration of the Leagues except for the following;

- A. On a particular weekend that the County Senior Football/Hurling Team is playing in its respective Championship, any player not named on the match day panel of 26 shall be free to play for his club.
- B. As the Connacht U20 FC is being played mid-week, the U20 Team Management will have absolute discretion as regards what players are released from inter county preparation to play with their clubs. Notification of such players to be made by Thursday 8pm in the lead up to such weekends by Team Management to CCC
- C. On any Spring League match weekend that Leitrim Senior Teams are not playing, certain players may be released from Inter County activity to play with their clubs. This facility will be at the absolute discretion of the County Team Managements. Notification of such players to be made by Thursday 8pm in the lead up to such weekends by Team Management to CCC Liatroma.

- D. Any player who leaves a County squad or in turn who is permanently released from squad may then play with his club.
- E. As the various County Teams exit their respective Championships then all players on each squad are free to play in the remainder of their respective club campaign.

17) Any player who is named on a match day panel of 26 and subsequently plays for his club on same weekend, the penalty for such action shall on a proven objection, lead to forfeiture of game with points awarded to the opposition. Minimum fine of €200.
