As Cathaoirleach of Coiste Chontae Liatroma, it is with great pleasure that I present a fundraising scheme for phase one of our two-phase infrastructural development programme for GAA in Leitrim, the redevelopment of Páirc Seán Mac Diarmada in Carrick-on-Shannon (Phase 1). On completion a Centre of Excellence will be developed in Annaduff (Phase 2).

Leitrim players and spectators alike have many fond memories of great occasions in this stadium, but I have no doubt you will agree that this development is long overdue.

Included in this project is the provision of a 3,000 seat covered stand, four new dressing rooms, shower rooms, training area, meeting rooms, kitchen and canteen, and press facilities. These will replace the facilities provided when the stadium was originally opened in 1964 and will bring conditions for everyone involved up to modern standards.

This redevelopment will not only provide Leitrim GAA with a superb new Headquarters but it will also greatly

In addition, it will generate valuable commercial benefits for businesses locally and in the surrounding area as it will enable the stadium to host many more major sporting events.

The Cost?

The new facilities will cost \in 3 million approx. While preliminary funding of \in 1.5 million has already been secured from the Department of Arts, Sports and Tourism, and the GAA, we are now appealing to Leitrim's loyal supporters and friends to help fund the balance by way of tax-efficient donations.

"Get on the Team"

Anyone making a donation to complete this project will be guaranteed a place on one of our teams. These teams will be known as 'The Teams that Built the New Stand' and in recognition each team will have its 15 players inscribed on one of the unique plaques that will adorn the wall at the entrance to Páirc Seán Mac Diarmada.

How does the Tax Relief Scheme work?

The Finance Act 2002 allows for a scheme of tax relief for relevant donations to an approved sports body for the funding of approved projects. The development of our new stand is an approved project and qualifies for the tax relief.

As the development is approved for tax relief purposes, you can claim tax relief on your donation. In addition your generosity will be acknowledged on a permanent "Team" plaque that will be prominently displayed on the wall at the entrance to Páirc Seán Mac Diarmada. You can choose your number on the team e.g., if you would like the full back position on a particular team you can choose the number 3 jersey.

PAYE Tax Payer

If you are a PAYE taxpayer and pay tax at either 20% or 42% you will be guaranteed your place on the team if you donate the following:

The above table shows if you are a 42% PAYE taxpayer and donate €4,350 to the Leitrim County Board you will secure your place on the BRONZE team.

If you are a 20% taxpayer and donate €4,000 to Leitrim Co Board you will secure your place on the GREEN team.

For Self Employed:

• In the case of a donation made by an individual who pays tax on a self assessment basis, the individual will be entitled to claim a tax deduction for the donation in computing his or her total income. A donation of €5,000 by a 42% taxpayer will cost the donor €2,900 and secure your place on the Green team.

For Corporate Donors:

• Similarly in the case of corporate donations, the company will be entitled to claim a deduction for the donation as if it were a trading expense in computing total profits of the company for the relevant accounting period.

To make a donation what do I do?

Decide which team you want to be on. You will fall into one of the following categories:

- A PAYE worker must complete the attached form and forward it to the County Board to allow it to claim back the
 grossed up amount of tax associated with the donation. This attached form is very straightforward and requires
 your name, address, PPS Number, amount of donation and signature.
- Self employed and Corporate Donors will receive a signed receipt from an officer of the County Board containing the name and address of the person making the donation, the amount of donation, and the date it was made. The receipt will clearly state that it is a receipt eligible for tax relief under Section 847A of the Taxes Consolidation Act 1997.
